# RESUSCITATION POLICY APPENDIX B 3 – EMERGENCY MEDICINES

### BACKGROUND

There are a number of medicines that are required for immediate or urgent administration in an emergency. These medicines are organised by priority as first, second- and third-line emergency medicines. This appendix will list the approved medicines for use in such situations and detail where they should be kept and how they are presented and stored within the trust. The safe storage and availability of these medicines remains the responsibility of the senior clinician in charge of each clinical area.

### FIRST AND SECOND LINE EMERGENCY MEDICINES

#### **RED** ADULT CARDIAC ARREST BOXES

First and second line medicines used in the management of cardio-respiratory arrest, will be stored in 'tamper evident' bespoke red coloured cases. These cases will be sealed with a breakable paper sleeve and marked with the soonest medicines expiry date. They will be located on all emergency trolleys and in additional specific clinical areas where there is a justified clinical need. Replacement boxes are located in the emergency drug cupboard located next to pharmacy. Out of hours please contact the nurse bleep holder on 401 to access this cupboard.

Where procurement of the approved medicines is not possible due to supply chain or manufacturing delays the Resuscitation and Deteriorating Patient Committee (RDPC) may temporarily agree to the substitution of an alternative formulation of any product affected and this will be communicated trust wide in a timely manner.

# THIRD LINE EMERGENCY MEDICINES

Third line emergency medicines, whilst not required for cardiac arrest, are required urgently in specific clinical emergencies. These will be stored as 'standard stock' in designated clinical areas. The following medicines (table 2) must be stocked in all designated clinical areas (table 3). Where a minimum quantity is specified the nearest whole equivalent pack size should routinely be stocked.

### **EMERGENCY ANAESTHETIC MEDICINES**

Medicines used during the emergency induction of anaesthesia are available in a clear plastic case in various fridge locations around the trust (table 5). <u>These medicines should only be</u>

**used by clinicians who are suitably trained and competent to do so.** The contents and timely review of the medicines contained within the anaesthetic box remain the responsibility of the Anaesthetic Department.
